5 YEAR LIMITED WARRANTY ON BREAKAGE

LEXAN[™] 9030P sheet will not break due to loss of impact strength when used indoors within five (5) year of the date of sale by POLYVANTIS India.

This limited written warranty is subject to the following conditions:

1.

The limited written warranty applies exclusively to standard uncoated LEXAN[™] sheet glazing produced by POLYVANTIS in India, used correctly as flat or curved glazing, handled, stored, processed, installed, and maintained according to POLYVANTIS India recommendations contained in the Technical Manual.

2.

This limited written warranty does not apply to sheet that has been scratched, abraded, or exposed to corrosive materials or chemicals.

3.

This limited written warranty is given only to the original purchaser of POLYVANTIS India sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to POLYVANTIS India the original sales receipt which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number, and the volume purchased. On request of POLYVANTIS India claimant must allow the material to be inspected on site and/or return the sheet to POLYVANTIS India for testing.

4.

For the purpose of this limited written warranty:

Mechanical properties after 5 years:

- A. The modulus of elasticity will be \geq 1700 MPa. The elastic modulus is measured in the tensile test according to ISO 527.
- B. The tensile strength will be \geq 55 MPa. The tensile strength is measured in the tensile test according to ISO 527.

5.

POLYVANTIS India reserves the right to investigate independently the cause of any failure.

6.

If a claim under this limited written warranty is justified, POLYVANTIS India will provide replacement material free of charge in accordance with the following schedule:

This limited written warranty shall be POLYVANTIS India sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. This warranty is in lieu of all other warranties (except of title), written or oral, statutory, express, or implied, including any warranty of merchantability or fitness of purpose. This warranty shall be governed by the laws of India.

This limited written warranty has been issued on December 3, 2019, and is restricted to LEXAN[™] 9030P material sold by POLYVANTIS India after such date and supersedes all previously issued warranties for LEXAN[™] 9030P sheet, sold after said date. The validity of this limited written warranty is restricted to LEXAN[™] 9030P sheet, and this limited written warranty is the sole warranty for LEXAN[™] 9030P sheet.

This limited warranty is valid for India, SEA & ANZ countries.
