

## WARRANTY CONDITIONS

# LEXAN™ SHEET F6000



### THREE (3) YEAR LIMITED WARRANTY ON BREAKAGE

LEXAN™ F6000 sheet will not break due to loss of impact strength when used indoors within three (3) years of the date of sale by POLYVANTIS.

### This limited written warranty is subject to the following conditions:

1.

This limited written warranty applies exclusively to LEXAN™ F6000 sheet produced by POLYVANTIS in Europe in all available colors used correctly as flat, curved, or formed sheet, handled, stored, processed, installed, and maintained according to POLYVANTIS recommendations.

2.

This limited written warranty does not apply to sheet that has been scratched, abraded, or exposed to corrosive materials or chemicals.

3.

This limited written warranty is given only to the original purchaser of POLYVANTIS sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to POLYVANTIS the original sales receipt which must contain the name and address of the purchaser, the date of the purchase, the complete product name, the lot number, and the volume purchased. On request of POLYVANTIS claimant must allow the material to be inspected on site and/or return the sheet to POLYVANTIS for testing.

4.

For the purpose of this limited written warranty:

Mechanical properties after 3 years:

- a. The modulus of elasticity will be  $\geq 1700$  MPa. The elastic modulus is measured in the tensile test according ISO 527.
- b. The tensile strength will be  $\geq 55$  MPa. The tensile strength is measured in the tensile test according ISO 527.

5.

POLYVANTIS reserves the right to investigate independently the cause of failure.

WARRANTY CONDITIONS

6.

If a claim under this limited written warranty is justified, POLYVANTIS will provide the purchaser with replacement material free of charge. Accordance with the following schedule:

Time from Orig. Purchase	Mechanical failure
Up to 1 year	100%
in 2 <sup>nd</sup> year	50%
in 3 <sup>rd</sup> year	15%

If replacement material cannot be provided within a reasonable period of time, POLYVANTIS may opt to refund the original purchase price paid to POLYVANTIS, or a portion thereof, in accordance with the above schedule.

7.

This limited written warranty shall be POLYVANTIS sole liability and customer’s exclusive remedy for the products and all other claims for damages are excluded. This limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express of implied, including any warranty of merchantability or fitness of purpose. This warranty shall be governed by the laws of the Netherlands.

8.

This limited written warranty has been issued on September 1<sup>st</sup>, 2024, and is restricted to LEXAN™ F6000 material sold by POLYVANTIS after such date and supersedes all previously issued warranties for LEXAN F6000 sheet, sold after said date. The validity of this limited written warranty is restricted to LEXAN F6000 sheet, and this limited written warranty is the sole warranty for LEXAN F6000 sheet.

This limited written warranty is globally valid.
